## **Board Comment:**

- \* Ted Henry Inquired about the Budget Public Hearing process.
- \* Eric Mays Requested that Ted Henry and Martin Cousineau help him to lobby for Flint's independence and control and educate people about all issues. He does believe that people don't understand how valuable KWA really is.
- \* Martin Cousineau indicated he appreciates Mr. Mays because he knows he will fight for Flint's rights to the last hour to maintain their assets.
- \* Joe Suma indicated he hopes the Mr. Gingell and Mr. Cischke can get their issues resolved at the earliest possible time for the good of all.
- <sup>\*</sup> Jeff Wright reiterated that any negotiations that involve Flint and the Great Lakes and any discussions that relate to the bond debt are decisions that have already been made by the Flint administration – not by the KWA Board. If Council members request changes, Mr. Wright recommended that talks be had with the individuals handling the negotiations on behalf of the City of Flint because the KWA Board has not been involved with that part. The fight is with the City of Flint Administration, not with this body.
