WHEREAS, Section 5(2) of Act 267 of the Michigan Public Acts of 1976, as amended, requires a public body to post within ten (10) days after the first meeting of the public body in each calendar or fiscal year a public notice stating the dates, tmies, and places of its regular meetings.

WHEREAS, Section 4(b) of Act 267 of the Michigan Public Acts of 1976, as amended, requires public notices of a public body to be posed at the principal office and any other locations considered appropriate by the public body, including cable television.

NOW, THEREFORE, BE IT RESOLVED THAT:

The second (2nd) meeting of the Karegnondi Water Authority Board shall be held on November 23, 2010, at 10 a.m., local time, at 4610 Beecher Road, Flint, Michigan 48532.

NOW, THEREFORE, BE IT FURTHER RESOLVED THAT:

The Chief Executive Officer, with assistance from the Secretary, shall establish a date, time, and location of the remainder of the regular meetings of the Karegnondi Water Authority. The Karegnondi Water Authority Board hereby directs the Chief Executive Officer with the assistance of the Secretary to ensure that a public notice stating the dates, times, and places of the Board's regular meetings is posted within ten (10) days of this first meeting of this Board.
